

Tax credits are available to individuals or married couples donating cash or marketable securities directly to approved NAP organizations. The minimum donation by an individual or a married couple must be at least \$500. The value of the tax credit is equal to 40 percent of the donation.

Example:

Minimum - \$500 cash donation X .40 = \$200 tax credit
