Update Regarding Summer P-EBT Issuance Delays

RICHMOND, VA (September 12, 2022) - In response to unforeseen delays in the release of Summer 2022 Pandemic EBT (P-EBT) benefits to eligible households statewide, the Virginia Department of Social Services (VDSS) has taken the following actions:

- Worked jointly with our state EBT card vendor to expedite the issuance of P-EBT cards to over 154,000 households scheduled to receive new cards. This includes reissuance of 90,000 invalid cards that were erroneously mailed due to a card processing issue. As of September 10, our vendor has mailed out all P-EBT cards to eligible families, including replacement of the invalid cards.
- Expanded our P-EBT Call Center with an additional 50 staff members to better serve our constituents and reduce call wait times.
- Identified process gaps, system improvements, and solutions to prevent future occurrences of P-EBT issuance delays.
- Partnered with the Virginia Department of Education to disseminate information to affected households via email, automated phone calls, and social media.

Similarly, VDSS is also actively supporting local school districts in rectifying specific data issues that have impacted the issuance of P-EBT benefits to some households in Portsmouth and Arlington County, as well as approximately 20 other school districts with 10 or less students with data issues to resolve.

VDSS is unwavering in its commitment to ensure the timely delivery of all benefits to Virginians. We will continue to prioritize our P-EBT work until all benefits have been issued to the 700,000 households eligible for summer P-EBT benefits. We sincerely apologize for the inconvenience this issue has caused and appreciate the patience we have been granted to maximize all available resources in order to resolve this issue as quickly as possible.

Eligible families can expect to receive benefits on P-EBT cards, or loaded onto existing EBT cards, by September 30. Additional updates and information are available at <u>PebtVa.com</u>.
