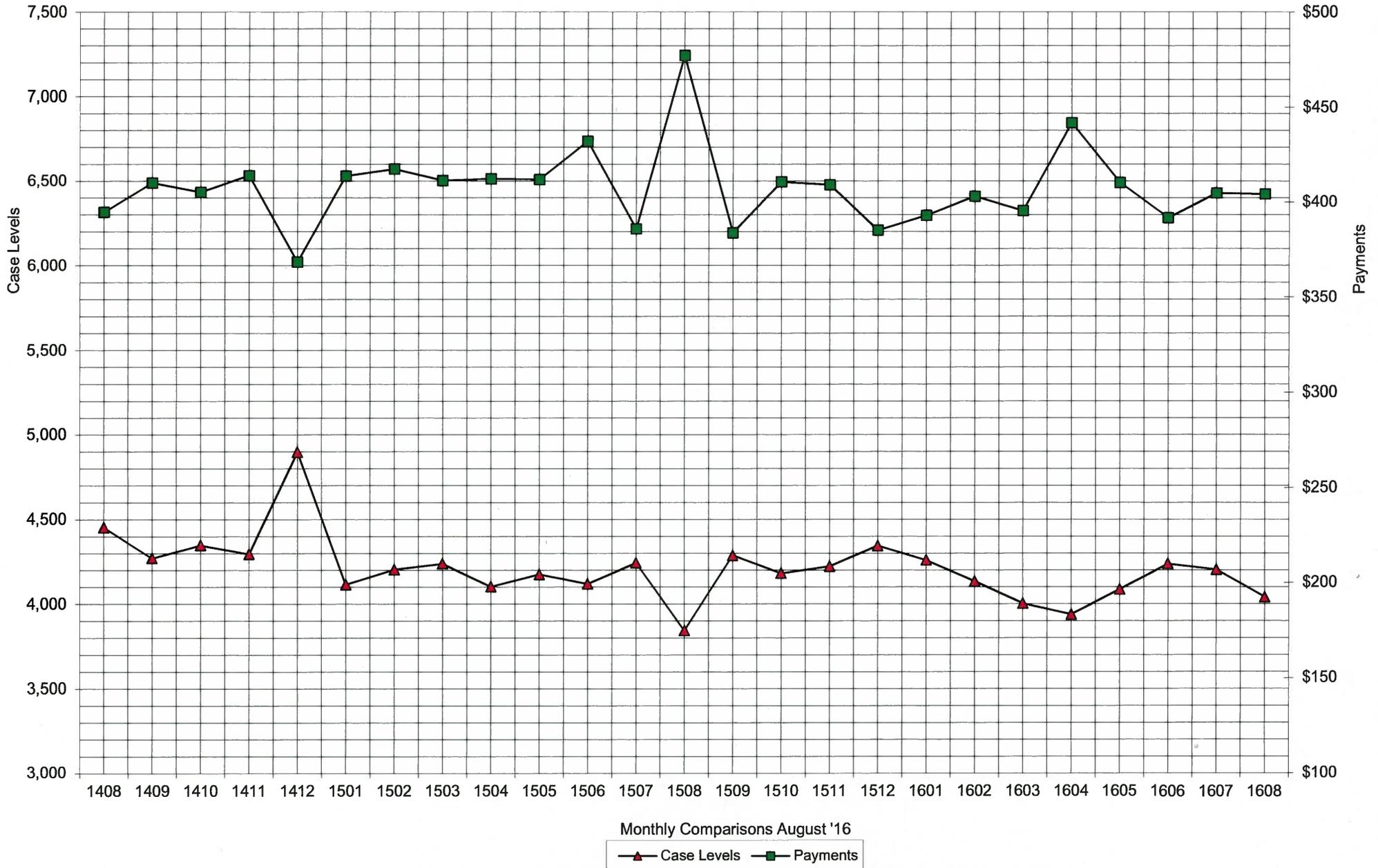

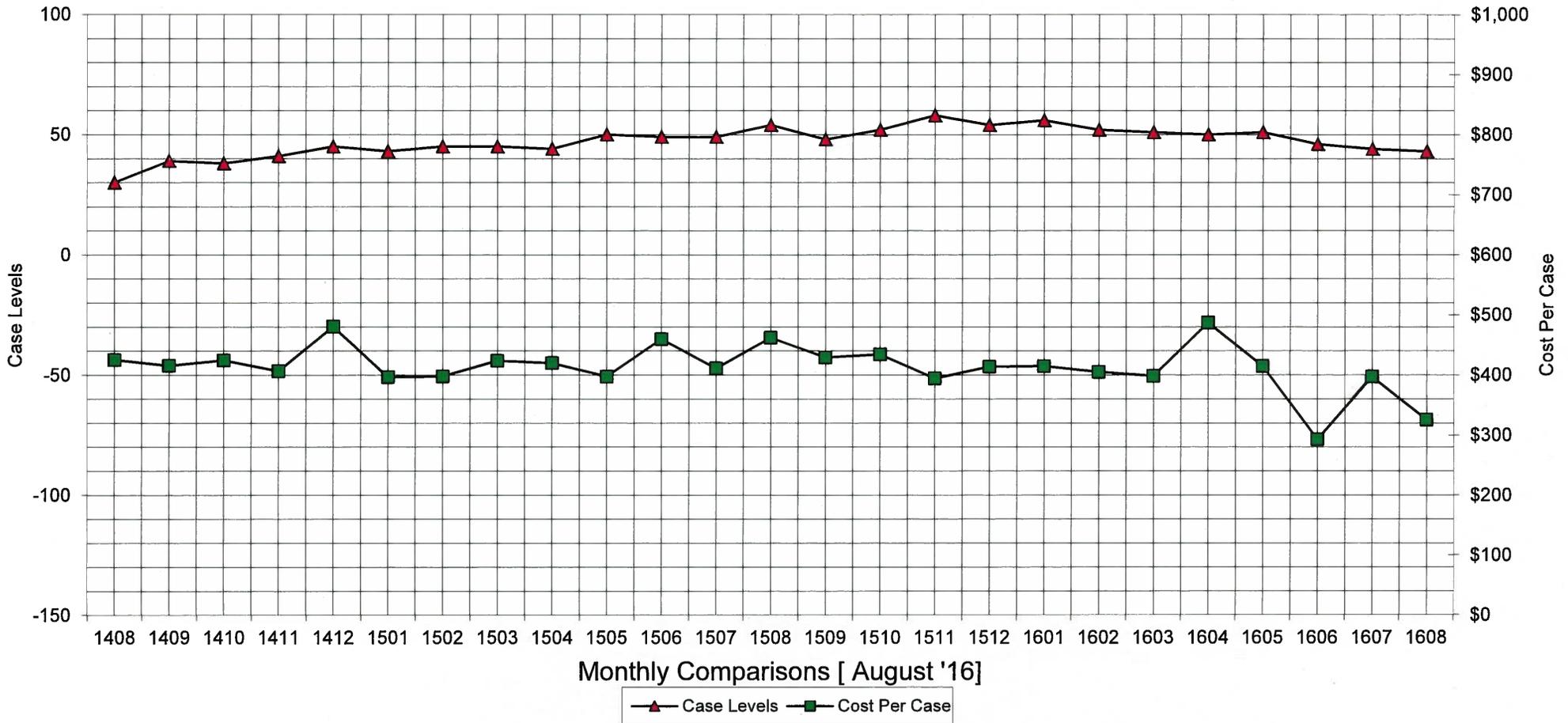

Effective March 2008 a difference method of calculating TANF & TANF-UP information was established.

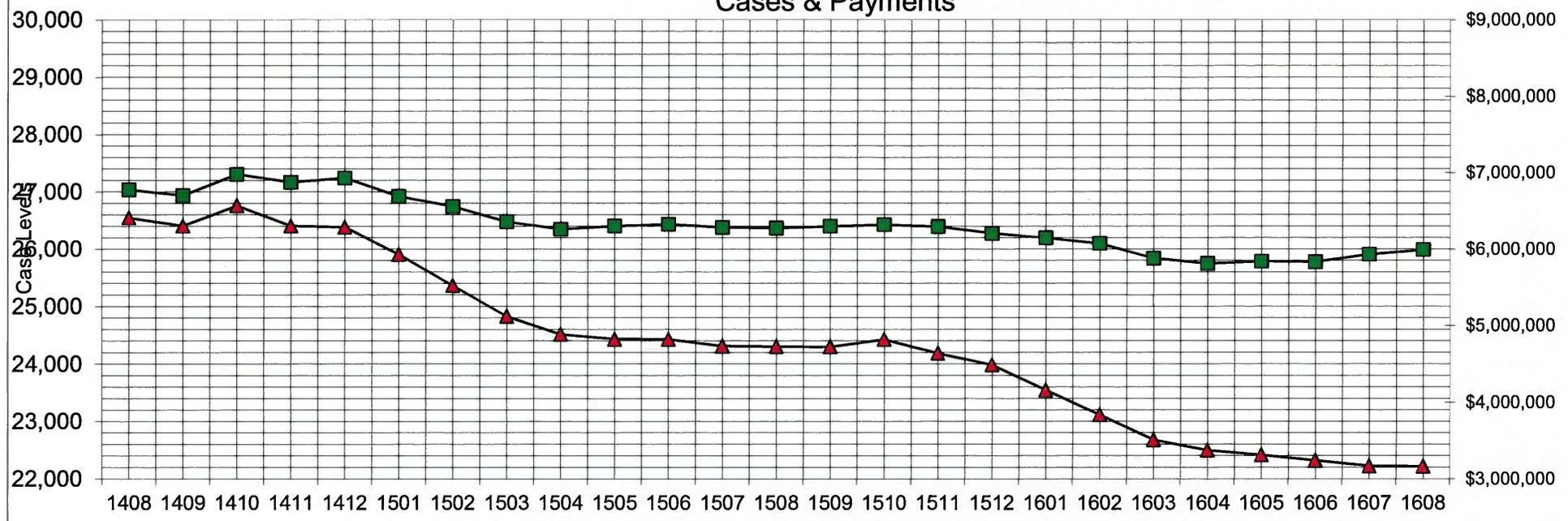
### Auxiliary Grants Programs Cases & Payments



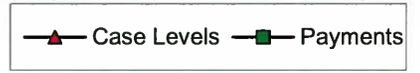
### Adult Foster Care Cases vs Cost-Per-Case
