Your inspector may check to ensure the following:

- ✓ Toys are safe and age-appropriate
- ✓ Safe sleep practices are in use
- ✓ Outdoor play areas are hazard free
- ✓ Caregivers can see and hear the children
- ✓ The appropriate number of children are in care
- ✓ Children in care are on the attendance list
- ✓ Proper caregiver records are maintained
 - ✓ Background checks
 - ✓ Medication training, *if applicable*
- ✓ Proper children's records are maintained
- ✓ Serious injuries are recorded and reported

Health and Safety Inspections

Children's Programs' licensing inspectors strive to promote safe and quality child care through routine inspections of facilities and homes throughout Virginia. During these inspections, child care providers are able to demonstrate compliance regarding proper systems and processes to promote quality standards for the children in their care.

? What should you know about your licensing inspector?

Inspectors:

- » Are knowledgeable in all aspects of the State’s licensure regulations and requirements for conducting health and safety inspections
- » Are highly qualified by education and experience
- » Receive initial and ongoing training
- » Complete the National Association of Regulatory Administration Professional Credential



? How will my licensing inspector and I work together?

- » The provider and the inspector are partners
- » You can ask for assistance and collaboration with new program ideas, additional resources and referrals for other services
- » You will exchange knowledge and experiences

? What can I expect at the end of my inspection?

At the conclusion, the inspector:

- » Performs an exit meeting - shares any areas of noncompliance
 - › You respond by providing a plan of correction, which explains how you will correct any areas of noncompliance identified in a violation
- » Answers questions regarding the interpretation and application of requirements
- » Provides technical assistance and refers additional resources
- » Provides documentation of the inspection findings
- » Remains available to assist with strategies and program enhancements



? What to expect when meeting my inspector for the first time?

As the inspector gathers information in your facility or home:

- » They treat you, staff and children in care with professionalism, dignity and respect
- » They help you feel comfortable while maintaining an open conversation
- » They enforce the regulations, remain objective, and provide consultation on how to improve your program
- » They ask questions so you can clarify your program’s rules and processes

? What can I expect during my inspection?

During the inspection the inspector will:

- » Observe children’s interactions, activities, environment and materials
- » Determine areas of strength and areas of improvement
- » Issue a Violation Notice, if noncompliance of the requirements exists

Think of the Violation Notice as a tool that helps identify any deficiencies in your facility or home that would cause potential harm or jeopardy to the children in your care.



? Will my inspection results be posted on the web?
