Getting Started



Before you begin, gather your documents and scan them to your computer to create electronic copies. You will need the following:

- Highest Diploma earned
- College transcripts, showing all child-related coursework
- Certificates, licenses and/or child-related credentials earned
- Certificates for other child-related professional development trainings completed

(All documents must be in an electronic form such as DOC, DOCX, TXT, GIF, PNG, PDF, etc.)


