The purpose of this transmittal is to provide revised guidance about the Adult and Family Services Manual, Chapters 2, 3 and 7. SB 115 (2012) recodified several chapters in Titles 26 and 37.2 of the Code of Virginia including:

- The Uniform Power of Attorney Act (formerly § 26-72 et seq. of the Code of Virginia)
- Guardianship and Conservatorship (formerly § 37.2-1000 et seq. of the Code of Virginia)
- The Uniform Adult Guardianship and Protective Proceedings Jurisdiction Act (formerly § 37.2-1031 et seq. of the Code of Virginia)

On October 1, 2012, these chapters moved to Wills, Trusts, and Fiduciaries, Title 64.2 of the Code of Virginia.

The provisions included in this transmittal are effective upon receipt.
