The State Board of Social Services is providing notice of intended regulatory action (NOIRA) to amend and conduct a periodic review of 22VAC40-151, *Standards for Licensed Children's Residential Facilities*. The NOIRA is available at

Proposed amendments in this action are intended to bring the regulation into alignment with state and federal requirements. The purpose of the periodic review is to determine the need for additional amendments or that the remainder of the regulation be repealed or retained in its current form. Notice of this intended regulatory action, will be published in the Virginia Register of Regulations on February 3, 2020. Public comment is being sought on the review of any issue relating to this regulation, including whether the regulation (i) is necessary for the protection of public health, safety, and welfare or for the economical performance of important governmental functions; (ii) minimizes the economic impact on small businesses in a manner consistent with the stated objectives of applicable law; and (iii) is clearly written and easily understandable.

The public comment period begins on February 3, 2020 and ends on March 4, 2020.
