SUBJECT: Regulation changes: Adult Day Center name change, effective August 14, 2024

The regulations, 22VAC40-61, *Standards and Regulations for Licensed Adult Day Centers*, 22VAC40-73, *Standards for Licensed Assisted Living Facilities*, 22VAC40-80, *General Procedures and Information for Licensure*, and 22VAC40-90, *Regulation for Background Checks for Assisted Living Facilities and Adult Day Centers*, have been revised to incorporate Chapter [150](#) of the 2024 Acts of the General Assembly that affects Adult Day Centers.

The amended regulations were published as final regulations in the Virginia Register of Regulations on July 15, 2024. The effective date of the amended regulations is August 14, 2024. This action was exempt from the full Administrative Process Act regulatory process because the purpose of the revision to each regulation was to incorporate the changes in state law.

The amendments made to the regulations change the name of Adult Day Care Centers to Adult Day Centers and each reference to the program throughout the regulations. **There are no new requirements in the amendments.**
