

Tab 3 – Auditing & Monitoring Tools

Background

Auditing and monitoring of infection prevention and control (IPC) behaviors/processes is an objective review process of specific ICP practices that uses structured and standardized documentation systems or tools to collect information. Auditing and monitoring compares staff performance of infection prevention behaviors to expected standards.

Auditing and monitoring benefits the IPC program by:

- Allowing providers to determine baseline behaviors and monitor adherence
- Identifying gaps and strengths in infection prevention practices
- Identifying educational and training needs
- Informing infection prevention program priorities
- Evaluating behavior change and educational/training outcomes

Purpose

This tab includes copies and links to a variety of auditing and monitoring tools from evidence-based sources as options for providers to use when auditing and monitoring staff performance of IPC behaviors/processes. These resources include the ***VDSS Site Self-Evaluation Tool*** which serves as a template for providers who wish to use it as a part of their auditing and monitoring programs to determine if implemented infection prevention and control practices are consistent with guidance from the Centers for Disease Control and Prevention (CDC) and individual facility policies and procedures.

Additional auditing and monitoring tool resources are provided that address the following IPC behaviors/processes:

- Performance of Hand Hygiene
- Use of Personal Protective Equipment (PPE)
- Environmental Cleaning and Disinfection
