Acknowledgement and Approval of Remote Participation by Board Members

The Chair noted that Zulma Santos and Les Ford requested to participate remotely. A physical quorum was present. Ms. Santos stated she was participating from Prince William County because of school-related commitments. Ms. Ford stated she was participating from home due to medical advice to avoid travel. ***On Motion Duly Made***, (Buckey Boone), second (Deronda Short), motion for the members to participate remotely approved with all in favor.

Comments from the Commissioner – Commissioner Williams reviewed agency priorities and provided an update on the Parental Child Safety Placement Program.

1. Approved June 2024 Meeting Minutes

2. 22VAC40-73, Standards for Licensed Assisted Living Facilities-Exempt Regulation

On Motion Duly Made, (Buckey Boone), second (April Morefield), motion to approve with all in favor.

3. 22VAC40-73, Standards for Licensed Assisted Living Facilities-Proposed Regulation

On Motion Duly Made, (Buckey Boone), second (Matthew Melvin), motion made to approve. Ms. Stewart noted the reasons for involuntary discharge (22VAC40-73-430.E.) are broad and vague. After discussion, a substitute motion was suggested, to table the proposed regulation to the October Board meeting, allowing time for the agency to add clarification and definitions regarding the reasons for involuntary discharge. A committee will be appointed to work with the agency in the interim. *On motion Duly Made*, (Deronda Short), second (Zulma Santos), motion to table Action Item #3 until the October Board meeting was approved with a vote of 5-4. Members voting in favor were Don Carey, Zulma Santos, DeRonda Short, April Morefield and Coke Stewart. Members opposed were Melvin Matthew, Maria Benjamin, Buckey Boon and Les Ford.

Summer EBT Update – Michele Thomas provided an update on the Sun Bucks program.

Medicaid Unwinding & Kinship Updates – Carl Ayers provided updates on Medicaid Unwinding and Kinship updates.

Appoint Ad Hoc Committee to Review Bylaws – The Chairman appointed William Boone, DeRonda Short and himself to serve on the committee.

In addition, the Chairman appointed Coke Stewart and Matthew Melvin to the Assisted Living Facility Appeals Committee. Ms. Stewart will chair the committee.
